(Revenue \$ ) Aviva Children's Services - The mission of Aviva is to enhance services that improve the quality of life for children who are in the care of Child Protective Services and who are victims of abuse, neglect and poverty. Funding from Angel Charity will help build an 11,000 sq. ft. Outdoor Visit Center to provide these children and their parents with the opportunity to play and visit in a safe, supervised park setting. The new Outdoor Visit Center is designed to maximize opportunities for positive family interaction through therapeutic play visits.

4b (Code: ) (Expenses \$ 100,000. including grants of \$ 100,000.) (Revenue \$ ) El Grupo Youth Cycling - El Grupo empowers youth through bicycles, so they can acquire the self-confidence, discipline and leadership skills to be active and healthy members of the community. Angel Charity funding will provide El Grupo Youth Cycling with funds for two years of additional staffing support. The additional staffing will enable El Grupo to extend their quality programming to more youths who are underserved or uninspired.

4c (Code: ) (Expenses \$ 500,000. including grants of \$ 500,000.) (Revenue \$ ) Girl Scouts of Southern Arizona - The objective of Girl Scouting is to provide girls with a safe and supportive environment. The grant from Angel Charity will go towards construction of the "Angel's Place For Girls" which will be part of the organization's planned Girl Scout Leadership Campus. The new building will provide thousands of girls throughout Pima County with a central, convenient place to meet and participate in activities that help build practical life skills and give them confidence.
